

These projects include system upgrades in our substations, overhead and underground power lines, installation and utilization of fiber optics, and the clearing of right-of-ways through our vegetation management program.

Working for Our Members | Operations

Project highlights from 2019 include rebuilding the IB Corners substation to allow for additional load growth and tie lines between substations in the Chestertown area; converting single-phase overhead lines to three-phase underground lines on Big Stone Road near Millington to reduce the number of storm-related outages due to tree damage; building a sub-transmission line from Oil City to Hobbs in the Denton area to provide for a more reliable feed for our Williston Substation as well as the Denton Industrial Park and Plaza area. Finally, installing additional fiber optic cable to enhance communications for our smart devices and data collection.



Vegetation Management

In addition to completing long-term capital projects to upgrade equipment and reliability, we also take other steps to reduce outages and secure reliability for our members. Vegetation Management is another way that we accomplish this goal. The primary mission of our Vegetation Management Program is to enhance reliable service to the Cooperative's members. To accomplish this mission, we use proven vegetation management activities such as tree trimming, tree removal, mowing, and herbicide application that conserves the vast natural resources of the Delmarva Peninsula found throughout our service territory.

Tree trimming and mowing operations have been primarily performed by Asplundh Tree Experts of Willow Grove, Pennsylvania since 2003.

In 2019, we trimmed 568 miles of line, mowed 601 acres of land, removed 6,211 trees, sprayed 536 acres

with herbicides, and responded to 402 member requests for service. As part of our restoration efforts, we have replanted 237 trees and transformed 1,157 acres of unmanaged lands into managed lands through reclamation activities.






How the Cooperative Dollar Was Spent



Assets (In Millions)




Equity as Percentage of Assets



Membership Account Growth Rate




kWh Sales (In Millions)




Number of Net Metering Accounts
