Choptank Electric may forgo the balloting process. This saves the Cooperative and its members thousands of dollars in printing and mailing the ballots, along with the costs of other voting services.

Because the Director election is uncontested and there are no proposed changes to the bylaws, no ballots will be mailed for the 2021 Annual Meeting.

Robert E. Arnold Queen Anne's County

Robert E. Arnold was appointed to the Choptank Electric Board of Directors in November of 2011. Arnold serves on the Board as the representative of Queen Anne's County.

Arnold is the owner of Arnold Farms, LLC, a vegetable growing business, and has been a Choptank Electric member since 1988. Arnold represents Choptank Electric on the board of the Virginia, Maryland & Delaware Association of Electric Cooperatives and sits on the board of Aero Energy.

Rites of Passage: From Apprentice to Journeyman

Lineman Appreciation Day is a celebration of the lineman journey.

Linemen are a major part of the workforce in the electric industry, but in the Co-op world, linemen are truly the heroes. They are our neighbors and friends. You see them cheering at baseball games, coaching little ones at soccer practice, making that last-minute grocery trip, and dining at the local deli on the corner. They understand, just like any other member of our community, what it is like to live, work, and play here on the Eastern Shore.

While there are many different rites of passage and positions in the linemen field, one of the most significant accomplishments is when an apprentice lineman graduates to a journeyman. Apprentice linemen train for four years before they can become a journeyman. They are taught skills by our Safety, Training, and Compliance Department, they learn the ropes from our chief linemen and servicemen, and they are led by their Manager of District Operations.

There were four apprentice linemen who graduated to Journeymen in the last year, and they all had different degrees of experience when they joined Choptank Electric: Andrew Benson, Matt Breeding, Thomas Iseman, and Ethan Wallace.

One thing they all seemed to agree on, is that even though they like climbing through the ranks (pun intended!), their focus remains on serving our members, helping their co-workers, and contributing to their communities.

Being a lineman can be a thankless job, but to the members who witness their skill and dedication in a moment of need, it means so much.

During this past Christmas Eve, in typical 2020 fashion, a storm blew through the Eastern Shore and created many outages for our members. Instead of being at home with their families, many of

"It takes a certain amount of selflessness to be a lineman," said Thomas Iseman. "I don't have kids personally, but many of the guys who were out there that night did, and they were missing their Christmas to restore power."

Are You Ready for Spring? Play It Safe!

Your Co-op's vegetation management best practices.

As your electric cooperative, it's our responsibility to provide safe, affordable, and reliable electricity to all of our members. Part of our strategy is to conduct proven vegetation management activities such as tree trimming, tree removal, mowing, and herbicide application. These practices conserve and enhance the vast natural resources of the Delmarva Peninsula that are touched by the Cooperative's maintained utility lines, while also providing your much-needed electricity.

Since May of 2003, all of Choptank Electric's tree-trimming and mowing operations have been performed by Asplundh Tree Experts of Willow Grove, Pennsylvania. Through the years, Asplundh has provided a mix of resources at a reasonable rate to assist the Cooperative in its effort to maintain vegetation and minimize its impacts on our infrastructure.

But what can our members do to help us maintain these rights-of-way?

Think Before You Plant

One of the simplest things our members can do is to "think before you plant." When you are looking at planting bushes, shrubs, or trees, look up and see if there are any power lines above, or near that spot. Some trees could grow up and interfere with power lines, so instead, think of planting shorter bushes or shrubs near those areas.



Call Before You Dig

Protect your property and your life by "calling before you dig" on any project this spring. Before you dig a new spot for your mailbox or install that new fence, call 811, which is a free service that marks out underground utility lines, pipes, and cables. This way, you aren't causing damage to any utility lines, which can disrupt service to an entire neighborhood, harm diggers and potentially result in fines and repair costs or potentially, your life. 811 will coordinate with local utility and service providers to mark underground lines based on a color code for easy interpretation.

The Choptank Electric Trust is a 501(c)(3) charitable foundation funded by Operation Round Up donations from members of Choptank Electric. Funds from the Trust are distributed in all nine counties of Maryland's Eastern Shore.
