# 2024 PETITION FOR NOMINATION OF CANDIDATE FOR DIRECTOR INSTRUCTIONS AND APPLICABLE BYLAWS

To the Credentials and Election Committee of Choptank Electric Cooperative, Inc.



Method of Submittal: The Petition for Nomination of Candidate for Director ("Petition") consists of Parts A, B, and C. The Petition must be delivered to Choptank Electric's headquarters office (10384 River Road, Denton) to the attention of Dawn Bowie by 4 p.m. on December 20, 2023. Incomplete petitions will not be considered. Petitions are reviewed by the Credentials and Election Committee ("C&E Committee"), not Choptank staff. Choptank staff is responsible for several administrative tasks, such as verifying Member signatures and performing background checks, but these are performed on behalf of the C&E Committee, not the applicants. It is the Member's obligation to verify the completeness of any Petition tendered.

<u>Part A:</u> The applicant is required to gather the minimum number of Member signatures as provided in the Bylaws (currently fifteen (15) members are required – see Bylaws §4.05(a)(1)(a)) in support of his/her application to be included for consideration by the C&E Committee as a Member running for election for a Directorship position. Extra spaces have been provided in the event that any signatories are not registered members and will not be counted toward satisfaction of the minimum signatures requirement.

<u>Part B:</u> These applicant-specific questions ask you to provide the C&E committee with the following information:

- 1. Type your full name.
- 2. Type all names or aliases you have used or gone by in your lifetime.
- 3. Print your date of birth.
- 4. Print the name of the Cooperative District for which you are seeking election (must match the District named on Part A of the form)
- 5. Print your street address, including street number and name, town, county and state. Note: Per Bylaws §4.04(a)(2), "Principal Residence" is defined as the location where you have resided for one hundred eighty-three (183) or more days in the preceding three hundred and sixty-five (365) day calendar year. Complete question 5(a) only if your eligibility is based on your employment by a qualifying Business Entity, as described in Bylaws §4.04(a)(1)(b)
- 6. This question seeks to determine whether you know of an actual or potential conflict of interest and if so, to describe the conflict to the C&E committee. See Board Policy 106, which is available on the Cooperative website. Attach as many extra sheets as necessary to complete your answer. If none, write "None."
- 7. This question seeks to determine whether you currently live in Choptank's Service Territory. Per Bylaws §4.03(a)(1)(a-c) and §7.01(a), "Service Territory" is defined as the

Cooperative's electricity distribution territory throughout the nine (9) counties comprising Maryland's Eastern Shore (Caroline, Cecil, Dorchester, Kent, Queen Anne's, Somerset, Talbot, Wicomico and Worcester).

- 8. This question seeks to determine whether you presently have any plans or intentions of moving out of Choptank's Service Territory during the upcoming year.
- 9. This question seeks to determine if you currently reside within the District for which you are seeking election.
- 10. This question seeks to determine if you are currently a registered voter in the District for which you are seeking election. This refers to voting registration for governmental elections, not Cooperative elections.
- 11. This question seeks to determine whether you presently have any plans or intentions of moving out of or away from the District for which you are seeking election at any time during the upcoming year.
- 12. This question seeks to verify that you are currently a Member in good standing of the Cooperative. See Bylaws §2.09(c)(1-3), for the definition of "Good Standing."
- 13. This question seeks to determine if you have any present intention of allowing your current good standing within the cooperative to lapse.
- 14. This question seeks to verify whether you received an Electrical Service to your residence. Please see Bylaws §7.02(a)(1) for the definition of "Electricity Service."
- 15. This question seeks to determine if you currently intend to receive at least one (1) Electricity Service continuously from the date you signed the form to April 25, 2027.
- 16. This question seeks to verify that as of April 25, 2024, will you be either at least eighteen (18) years old, or a legally emancipated minor.
- 17. This question seeks to verify that you are legally competent to enter into a binding contract.
- 18. This question seeks to ascertain your highest level of education completed.

Questions 19 through 23 seek to verify that, if elected as a Director, you are willing to discharge the listed duties and obligations to which all Directors are required to adhere.

Questions 24 through 25 seek to ascertain information related to a criminal background check.

- 26. This question seeks to ascertain whether you have been an employee of the Cooperative, or an employee or director of a competing utility at any time during the past ten (10) years.
- 27. This question seeks to determine whether you presently plan or intend to become an employee of the Cooperative in the next four (4) years.

- 28. This question seeks to determine if you have previously been employed by a labor union that represents, or attempted to represent, any employee of the Cooperative.
- 29. This question seeks to determine if you reasonably expect to be employed by a labor union that represents or attempted to represent any employee of the Cooperative.
- 30. This question seeks to determine if you reasonably expect to be a Close Relative of any employee or Director of the Cooperative? (Per Bylaws §3.14(a), "Close Relative" is defined as an individual who (1) by blood, law or marriage, is a spouse, fiancé/ee, sibling, stepsibling, half sibling, sister-in-law, brother-in-law, parent, step-parent, mother-in-law, father-in-law, child, son-in-law, daughter-in-law, step-child, grandchild, grandparent, niece, or nephew of the first individual, or (2) resides in the same dwelling with the first individual.)
- 31. This question seeks to determine if you have any current plans to work for or to become financially interested in any competitor or major supplier of the Cooperative.
- 32. This question seeks to determine if you have any current plans to become a full-time employee of, or a full-time employer of, a current Director.
- 33. This question seeks to determine that you have the time to devote to attendance at meetings, training, and other activities regarding the Director position for which you are seeking election.
- 34. Type the requested contact information; you are further consenting to being contacted by the C&E Committee and you are verifying the information you have provided is correct.

<u>Part C:</u> This final section seeks to determine that you are representing and warrantying that the information you have provided to the C&E Committee is true and correct to the best of your knowledge, information, and belief.

- 1. This assertion verifies that the nominee is consenting to be contacted in relation to this form by the C&E Committee.
- 2. This assertion verifies that the nominee has read the Bylaws concerning this form and knows where the Bylaws are located on the Cooperative's website.
- 3. This assertion verifies that the nominee represents that all information, as written, in the form is true and correct, to the best of his/her information, knowledge and belief.
- 4. This assertion verifies that the nominee is obligated to submit a form if and when the information contained in the form has changed, and that change signifies a deviation from the nominee's qualifications for the position of Director.
- 5. This assertion verifies that the nominee represents that all information, as written, in the form may be published in the Cooperative's publication, *Cooperative Living*, and that the nominee agrees that a bio may be published in advance of the next annual meeting.
